BIOGRAPHICAL/HISTORICAL NOTE

Albert Agrippa (A. A.) Batchelor, son of Thomas A. G. Batchelor (1813-1868) and Martha L. Batchelor (1821-1862), was a doctor and planter of Red River Landing in Pointe Coupee Parish, Louisiana. He attended the Kentucky Military Institute and fought for the Confederacy with the 2nd Regiment, Louisiana Infantry. Batchelor also managed or had interests in several other plantations, including Bella Vista Plantation, Lakeside Plantation, Phoenix Plantation, Highland Plantation, and Normandy Plantation. Batchelor served on the Pointe Coupee Parish Police Jury, the School Board of Pointe Coupee (1884), and was elected to a term in the Louisiana State Legislature (1888-1892). He married Cornelia Randolph Stewart (also known as "Pet"), daughter of Gus Stewart, and the two had no children.

Batchelor's siblings are also represented in the collection. They include Mollie, Iverson G. (1846-1900), Charles J. (1838-1878), James Madison, Thomas (circa 1850-1868), and Kate. All the brothers of age also served in the Confederacy--Charles and James alongside Albert in the 2nd Louisiana, and Iverson in the 1st Louisiana Cavalry. Iverson was also involved with running the family plantations and acquiring additional land. James Madison eventually settled in Vicksburg, and Mollie in Baltimore, after marrying a Mr. Patton. Many of the Batchelor family members are buried in St. Stephen's Episcopal Church Cemetery, Innis, Pointe Coupee Parish, Louisiana.

SCOPE AND CONTENT NOTE

Personal and business papers of Albert A. Batchelor and family, planters of Red River Landing, Pointe Coupee Parish, including account books and related papers, correspondence, diaries, and contracts and leases. The collection relates principally to plantation operation and management of several plantations in Pointe Coupee Parish, including a considerable body of materials reflecting the transition from slavery to free labor economy and certain economic, social, and political problems inherent in that change. The materials also pertain to student life at school in Louisiana, Kentucky, and Mississippi prior to and during the early years of the Civil War; military service in the Confederate States Army and life on the home front during the war; study of medicine at the University of Louisiana; expressions of public opinion on rechartering the Louisiana State Lottery, 1890; and family life and related matters. Civil War letters include 15 letters that describe camp life and conditions, rations, and battles from the Confederate side and two letters that describe marching and the courteous treatment of CSA troops by Pennsylvania civilians.

Financial papers include invoices, receipts, promissory notes, etc. from the following New Orleans merchants: Richard Flower and Maes (1866-1868); Bloch Brothers (1867); Sam Stafford and Co. (1870-1872); Richard Flower and Co. (1871-1873); Clapp Brothers and Co. (1872-1876); Butts and Ogden (1872); O. Hopkins (1872-1873, 1877); J. U. and H. M. Payne and Co. (1873); L. Mische and Co. (1874); Payne, Kennedy, and Co. (1875); Norwood and Richards (1875-1877); A. Thompson and Co. (1876); S. Gumbel (1876); McGehee, Snowden, and Violett. (1877); and William C. Black and Co. (1877).

Printed and graphic items in the collection are newspaper clippings, photographs, pamphlets, recipes, manuscript writings, blank forms, and medical notes. Larger items have been placed in a separate series for oversize and include land grants, plats, insurance policies, agreements, floor plans, etc. The oversize items that are too large to be housed in box 82 are stored separately in folders at OS:B. A few full-size Louisiana newspapers covering the dates 1870-1900 reside in the collection as well. Manuscript volumes such as cashbooks and checkbooks, ledgers, memorandum books, notebooks, letter books, and scrapbooks are also present.
