**LSU Libraries Special Collections**  
**Information, Instructions, Pricing**  
**Effective July 1, 2015**

**All duplication of Special Collections materials requires prior approval of a library staff member** and must be placed through our Aeon patron management system.

**Published materials (books, journals, etc.):** Self-service photocopying of books is allowed if condition, value, age, and/or copyright restrictions do not apply. Patrons should request permission before any self-service copying takes place. If the book is at risk of damage or already in poor physical condition, other options may be used to provide copies, such as scanning or digital photography. Self-service photography (no flash) with prior approval and requires a form provided by the reference staff member on duty.

**Manuscript materials:** Manuscript items must remain in their folders and in order. We do not allow self-service photocopying or the use of personal scanners to scan manuscript materials. With prior approval, self-service photography (no flash) may be permitted.

**Photographic materials:** Photographs must not be removed from their folders or protective sleeves. Reproductions of photographs may be obtained only through staff-produced digital scans or photographic prints. Alternately, with prior approval, self-service photography (no flash) is allowed. We do not allow photocopying of photographs of any kind, nor is the use of personal scanners to scan photographs permitted.

**Fees.** Fees for duplications services are listed on the back of this sheet.

#### **COPYRIGHT**

Copyright protects the rights of the creators of published and unpublished original works to reproduce, prepare derivative works, distribute copies, perform, or display the work publicly. Generally, published works created and published before 1923 are in the public domain, while those created or published on or after January 1, 1978, are protected from creation throughout the life of the creator plus 70 years after the creator's death. Unpublished works such as historical manuscripts are protected from the life of the author plus 70 years. If the death date of a creator of an unpublished work is unknown, the work is protected 120 years from its creation. A minimum processing fee of \$10 will be charged for requests unless the requestor identifies materials, places the order, and pays for it in person upon completion of the order, in which case the processing fee is waived. If applicable, postage will be added.

<b>Staff-produced</b> photocopies or scans from microforms	\$1/copy or scan plus processing fee. <i>Limit of 30 scans.</i> (Scans delivered by email or file download.)
<b>Staff-produced</b> , high-resolution scans suitable for publication	\$5/scan delivered by email or file download, plus processing fee assessed at time of order. \$10/large format scan delivered by email or file download, plus processing fee assessed at time of order. Additional charge of \$5 for CD/DVD delivery, per CD/DVD
Remote digital access of microfilm	\$20/session. Contact Public Services in advance to schedule.
Duplication of microfilm (with negative held by LSU)	\$175 per reel
Photographic prints	\$20.00/print and up depending on size
Cassette to digital audio	\$5 per interview session
Reel to digital	\$100 per hour of tape
Interview transcript (pdf) from pre-existing digital file	\$5 per interview session
Interview transcript (pdf) from paper transcript with OCR	\$0.30/page
