BIOGRAPHICAL/HISTORICAL NOTE

Huey Pierce Long was born on August 30, 1893, in Winnfield, Louisiana. He briefly attended the University of Oklahoma School of Law in Norman, and later Tulane University Law School in New Orleans, Louisiana. He practiced law in Winnfield and later in Shreveport, Louisiana. Long was a member of the Louisiana Railroad Commission (later the Louisiana Public Service Commission; 1918-1928), governor of Louisiana (1928-1932), and U.S. Senator from Louisiana (1932-1935). Known for his social reform programs, Long was accused by his opponents of dictatorial tendencies for his near-total control of the state government. He was shot on September 8, 1935, at the Louisiana State Capitol in Baton Rouge and died two days later at the age of 42.

SCOPE AND CONTENT

Collection includes general, family, congressional, and legal correspondence; impeachment documents; radio speeches; book accounts; senatorial campaign accounts; Public Service Commission records; case files for lawsuits against railroads, oil companies, gas companies, and other corporate bodies and individuals; various printed items; and photographs.
