# **ROBERT RAYMOND REID PAPERS**

1875-1949

#### **BIOGRAPHICAL/HISTORICAL NOTE**

Robert Raymond Reid was an attorney of Amite, Tangipahoa Parish, Louisiana. He served as a judge in the 18th (1892-1900) and 25th (1900-1904) District Courts, was a member of the Louisiana Constitutional Convention (1921), and was an associate justice of the Louisiana Supreme Court (1923).

#### SCOPE AND CONTENT NOTE

This collection consists of correspondence, legal and financial papers, printed items, and photographs. Papers reflect to the legal career of Robert Raymond Reid, business affairs and family matters. Letters also mention political patronage and the electoral defeat of Samuel Douglas McEnery in the Louisiana gubernatorial election of April 30, 1892 (1896). Letters explain aspects of the Illinois Central Railroad Company and passenger train service in eastern Louisiana (1898). Other topics include education and economic conditions in Tangipahoa. One letter relates to the problems posed by the behavior of a schoolteacher (April 29, 1899).

Legal papers include a petition (1900) submitted by white citizens of Ponchatoula requesting the release of two jailed African American youths. The collection also contains bills and receipts, newspaper clippings, postcards, land plat maps of Lachnagan Plantation, and photographs of unidentified individuals (undated).
