Papers (1831-1919) consist of correspondence, notes, and printed items. Journals (1844-1880) contain diary entries describing daily personal and professional activities; social life; contemporary political events and figures; and travel in the South, to Washington, D.C., and to Yellowstone National Park. Legal notebooks and memorandum books (circa 1840-1894) record William Raymond McLaws's attitudes toward legal decisions. Some volumes contain educational notes from the early 1840s. An autograph album of Mollie Morgan (1883) and a scrapbook are included.
